- The first 1000 to finish will receive medals.
- The Fun Run starts at 07:00 (8km) and 07:10 (5km).
- The map of the route will be displayed at the venue.
- Distance markers at every 1km.
- The cut-off time for both distances (8km and 5km) is 2 hours.
- Toilet facilities are available at the venue.
- Refreshments will be sold. No gas braais are permitted.
- Participants should please stay for the prizegiving ceremony and lucky draw at 09:00.
- Runners and walkers are both welcome.
- Children under 9 must always be accompanied by an adult.
- All athletes participate at their own risk and by their entry, they indemnify the organizers, province and sponsors of any liability or claims – see indemnity.
- The marshalls and traffic officials must be obeyed at all times.
- No seconding will be permitted.
- Watering points will be at the 2.5km and 5km mark. Refuse bins will be put out, please discard used water sachets into or near these bins.
